FBI Offer for 9/11 Coin and Certificate Available to WTCHP Registrants

On September 11, 2001, and in the aftermath, many FBI employees assisted with the rescue, recovery, and investigative efforts in New York City (at both the World Trade Center and Staten Island Landfill), at the Pentagon and related evidence sites, and in Shanksville, Pennsylvania. Other affected employees include those assigned to the New York Field Office between 9/11/2001 and 7/31/2002, after much of lower Manhattan was designated as a 9/11 Disaster Area. As a result, more than 15 FBI employees have died from 9/11-related illnesses and many others are facing medical as well as mental health conditions.

The federal government has programs that provide benefits to affected employees or surviving family members. They are the World Trade Center Health Program (WTCHP) and the Victim Compensation Fund (VCF). The FBI wants every affected employee to register, even if there are no current symptoms of illness.

For those current or former employees who are registered with WTCHP, the FBI offers this specially designed coin and

certificate without charge. Only those who are registered with WTCHP are eligible to receive this coin. To obtain your coin, you must return the completed form below with **a copy** of your WTCHP registration to the FBI 9/11 Responders Benefit Program via mail, email, or fax.

The FBI 9/11 Responder Benefits Program: After recognizing the long-term health effects on 9/11 responders and survivors, the FBI established the FBI 9/11 Responders Benefit Program (RBP) to assist current and former eligible employees with registration for 9/11 benefit programs. These federal programs offer health screenings, medical treatment, and compensation. Your information and discussions are confidential and restricted to RBP staff.
